Section 3. Composition and Information on Ingredients

Botanical Name: Symplocos cochinchinensis
Part of Plant: Leaves
Preparation: Fallen leaves are dried and ground to a powder

Section 4. First Aid Measures

General advice: Do not take Internally. Avoid contact with eyes. Wash thoroughly with soap and water after handling and before eating.
If swallowed: Drink water.
If in eyes: Hold eye open and rinse slowly and gently with water for 5 minutes. Remove contact lenses, if present, after 5 minutes, then continue rinsing.
If on skin or clothing: Rinse skin with plenty of water.
